Stockbroker in Control

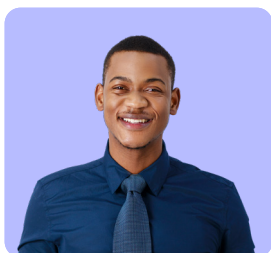

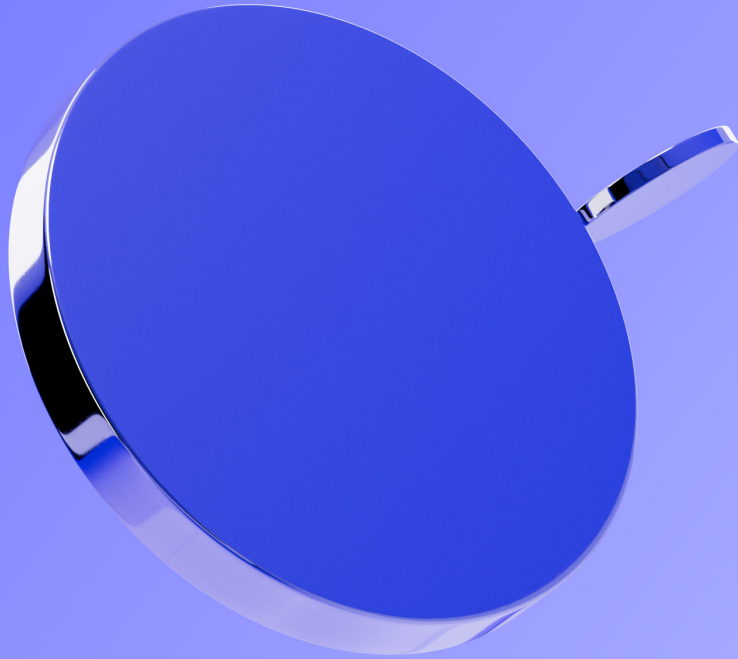
Paul Gomes
